## **■ Introduction**

These guidelines provide guidance for those who wish to enjoy secondary creation using “Futaba Kominato” (a character planned and managed by Gasoline Alley Inc.), which is included in VoiSona developed by Techno-Speech, Inc. (“Company”), as well as for those considering commercial use.

We hope that you will enjoy your creative activities using “Futaba Kominato” after reading these guidelines.

## **■ Rules for Voice Use (Futaba Kominato Commercial Use Guideline)**

When using voice waveforms output from VoiSona’s “Futaba Kominato” Voice Library, whether for non-commercial or commercial purposes, please list “Futaba Kominato” in the credits as the name of the character used.

For non-commercial use of synthesized voice output from VoiSona’s “Futaba Kominato” Voice Library, you may use it free of charge and without the permission of the Company or Gasoline Alley Inc. (\* There are some exceptions where certain uses are prohibited, such as incorporation into other musical instruments. For details, please refer to the [“VoiSona Terms of Use”](#))

For commercial use of synthesized voice output from VoiSona’s “Futaba Kominato” Voice Library, you may need to obtain permission from Gasoline Alley Inc. or pay a commercial usage fee to Gasoline Alley Inc.

\* Please refer to “Rules for Character Use” below when crediting “Futaba Kominato”

\* It may be possible to use voice soundwaves output from “Futaba Kominato” Voice Library without credit by obtaining a separate agreement from Techno-Speech, Inc. and Gasoline Alley Inc..

## **■ Rules for Character Use**

## **■ Prohibitions**

Refrain from using the character in the following expressions or contents.

- Content that violates public order and standards of decency or that is antisocial;
- Content biased toward a particular ideology, creed, religion, or political belief
- Content that infringes on the honor or dignity of a third party, or that infringes on the rights of a third party.
- Content that could be misunderstood or misinterpreted as official content planned by the Company or Gasoline Alley Inc.;
- Content that seriously damages the image of the Company, its products, or its characters;
- Content that seriously damages the image of Gasoline Alley Inc., its products, or its characters;
- Any other content that the Company or Gasoline Alley Inc. deems inappropriate.

The usage rules for the Japanese talk voice library “VoiSona Talk Futaba Kominato Lite” included with the packaged version or other distributions of this Project shall follow these guidelines.
