These guidelines provide guidance for those who wish to enjoy secondary creation using "Decentralized Autonomous Golem REML" (a character planned and managed by Bandai Namco Entertainment Inc.; BNE), which is included in VoiSona developed by Techno-Speech, Inc. ("Company").

We hope that you will enjoy your creative activities using "Decentralized Autonomous Golem REML" after reading these guidelines.

■ Rules for Voice Use (Decentralized Autonomous Golem REML Commercial Use Guideline)

Content using voice waveforms output from VoiSona's "Decentralized Autonomous Golem REML" voice library ("user content") can be used free of charge for non-commercial, non-business purposes. Even if you obtain compensation using user content, you can use it free of charge for the following individual uses on the condition of credit attribution. Please credit the name of the voice library character as "Decentralized Autonomous Golem REML" or "REML."

- a. Posting user content on SNS, still image, and video sharing sites, and earning revenue through standard advertising revenue models or monetization programs officially provided by those sites.
- b. Recording user content on media such as CDs or DVDs and selling it individually or through doujin circles.
- c. Selling user content for a fee via download or streaming through designated digital music aggregators (hereinafter referred to as "designated aggregators").
